## Endeck Forest Series Cleaning and Maintenance Guide

Enduris Forest Series products are aesthetically pleasing, durable and easy to maintain. Like all other low maintenance exterior products that are regularly exposed to the elements, capped cellular decking will require cleaning from time to time. With very little effort, you can keep your product clean. In most cases only water from Mother Nature or a hose is required. If stains are a little more stubborn, just follow these easy instructions:

- Wash Endeck Forest Series product with a soft cloth or long handled soft bristle brush (similar to what you would use on your vehicle).
- If the stain is difficult to remove, wipe down with one cup of Simple Green® or equivalent mixed with one gallon of water. The solution can be put in a spray bottle, sprayed on and wiped off quickly with a soft cloth. You can also mix 1/3 cup mild detergent such as Tide® or equivalent, 2/3 cup household cleaner such as Spic & Span® or equivalent with one gallon of water. Rinse all cleaners with water before they dry.
- Should more persistent stains exist, refer to the chart below. Follow the precautionary instructions on the container label. Protect all vegetation from direct contact with the cleaning agent.

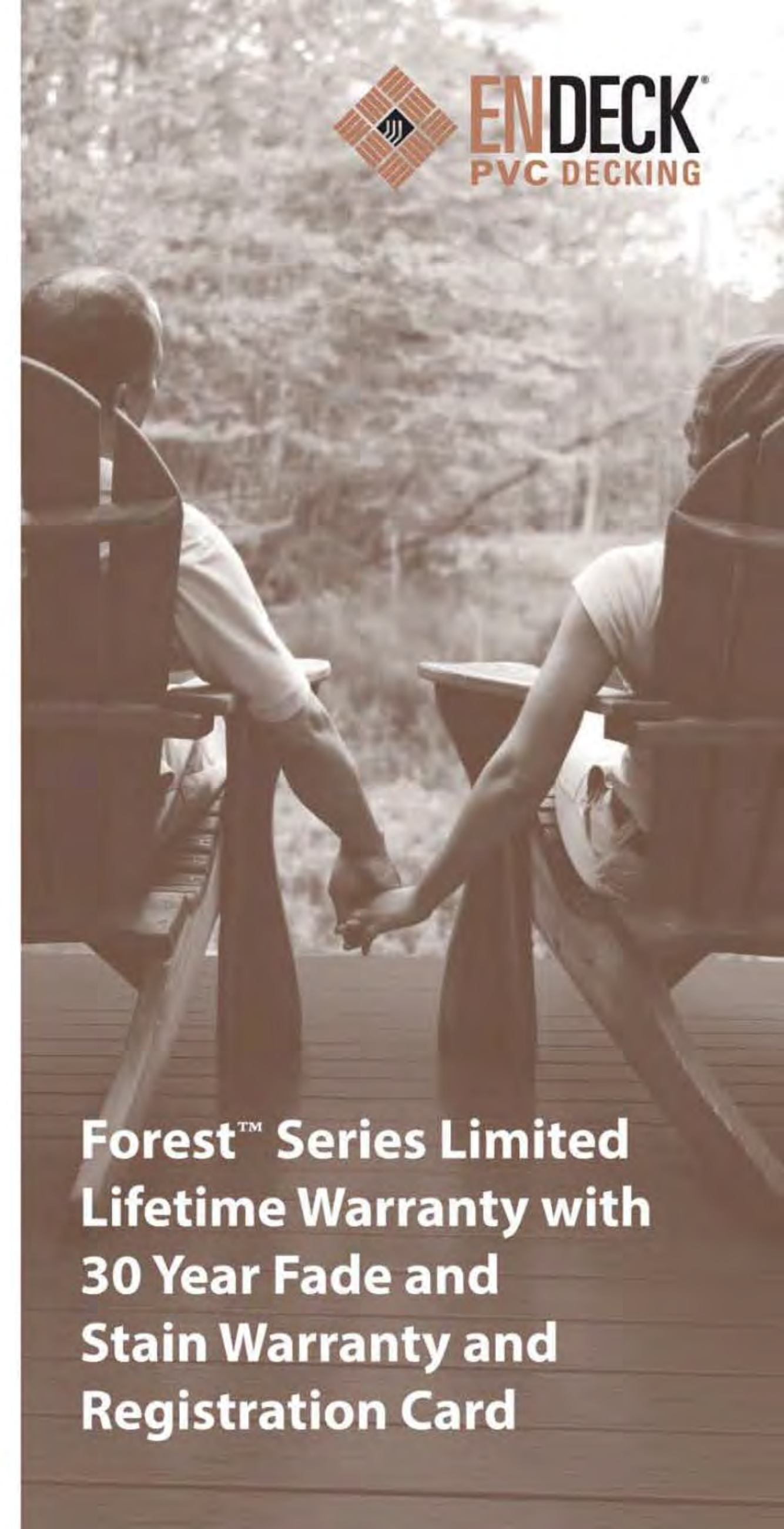

## Limited Lifetime Warranty

with 30 Year Limited Fade and Stain Warranty

### WARRANTY STATEMENT

Endeck Forest Series is warranted by Enduris (manufacturer), in accordance with the terms and conditions set forth below, to be free from material defects and workmanship that occurs in visible form such as cracking, peeling, splitting, cupping, blistering, flaking, rotting, or structural defects from termites or fungal decay.

### NOTIFICATION

If purchaser discovers a defect in the Endeck Forest Series product, purchaser must, within 30 days from the discovery of alleged defect and prior to beginning of any repair or alteration to the Endeck Forest Series product, notify manufacturer with a detailed description of the claimed defect, photographs of the defect, and proof of purchase to the following address:

After reviewing all information, manufacturer will make a determination regarding the validity of said claim. If manufacturer determines that purchaser's claim is valid, manufacturer will, at its discretion, either replace or repair the defective Endeck Forest Series product or will refund the original purchase price of the defective material not including the cost of installation. The choice of remedy is in the manufacturer's sole discretion. The manufacturer will not be liable for labor and/or removal costs connected with the claim. Replacement product will be provided as close to the original color as possible, although it is not guaranteed to match completely. In the event of replacement or repair, the original warranty shall apply to the replaced or repaired portion of the manufacturer's products and will be extended for the balance of the warranty period in effect at the time the material proved defective.

### WARRANTY TRANSFER

This warranty, subject to return of warranty registration card, can be transferred one time within a five-year period beginning from the date of original purchase by purchaser to a subsequent buyer upon which the manufacturer's products were originally installed. To transfer this limited lifetime warranty, owner must provide Enduris with written notice within 30 days after the transfer. The written notice must include the name of the owner and purchaser address of the real estate upon which the product was installed and date of transfer.

### FADE RESISTANCE

The products shall not fade in color from light and weathering exposure as measured by color change in excess of 5 Delta E Units. No exterior material is fade-proof when exposed to years of harsh UV rays and the elements. Endeck Forest Series is designed to resist fading, and will not, in any event, fade more than 5 Delta E Units.

### STAIN RESISTANCE

Forest Series shall be resistant to permanent staining resulting from spills of food and beverage related items that would typically be present on a residential deck, or mildew and mold naturally occurring in the environment providing spilled material must be removed within one week of the spill using mild household soap and water. After the initial cleaning, if the stain remains, refer to the cleaning guide table on back of this document. Enduris does not warrant stain resistance resulting from spills that are not cleaned properly within a timely manner or mildew and mold which has grown on a foreign matter not removed. In addition, materials not covered in this stain resistance include, but limited to, suntan lotion, stain, paint, strong solvents, abrasive compounds of acidic or basic pH, biocides, fungicides, and metallic rust.

### REMEDY: FADE AND STAIN

The term of this limited warranty shall begin on the original purchase date, and shall end thirty (30) years thereafter for single family and residential purchases and fifteen (15) years thereafter for commercial purchases on the fade and stain warranty.

If a valid fade and/or stain warranty claim is made during years sixteen (16) through thirty (30), after the original purchase date by a residential purchaser, recovery will be prorated. If Enduris elects to replace the percentage noted below of boards, otherwise meeting the requirements for a claim, or if refunding the purchase price, Enduris may elect to refund the percentage listed below of the purchase price of boards, not including the cost of installation, otherwise meeting the requirements of the claim.

### WARRANTY EXCLUSIONS

This limited lifetime warranty is void if any of the following occurs: 1) Improper installation of the manufacturer's products and/or failure to abide by the manufacturer's installation guidelines, 2) Movements, settling, distortion, collapse of the ground or support structure on which the manufacturer's products are installed and improper ledger board attachment, 3) Naturally occurring casualties including impact of objects, earthquakes, tornadoes, hurricanes, flooding, lightning or any acts of God, 4) Improper handling or storage, neglect or misuse of the manufacturer's products either by the purchaser or third parties, 5) Improper application of paint or other surface chemicals not recommended by the manufacturer in writing, 6) Use with vinyl or rubber backed mats not clearly marked "safe for use with vinyl", 7) Adverse effects of air or water pollution, 8) Normal weathering of surfaces, 9) Uneven surface due to condition of substructure, 10) Staining from foreign substances. 11) Stain, paint, or other non-approved applied coatings. Due to UV conditions in desert climates, manufacturer warrants weatherability over a life of twenty (20) years to be equivalent to other PVC products sold in desert climates, with remedies limited to material replacement only.

### OTHER CONDITIONS

The manufacturer does not recommend the Endeck Forest Series products for all end-use applications. The manufacturer's products are intended for decks, balconies, boardwalks, and piers. Local code authorities should be consulted before installation of structures with specific load bearing capabilities and other zoning code regulations. The purchaser is solely responsible for determining the effectiveness, fitness, suitability and safety of manufacturer's products in connection with their use in any particular application. This limited lifetime warranty is valid for single family and residential applications only. For all other applications, including commercial use, this warranty shall be limited to a period of twenty (20) years.

Manufacturer reserves the right to discontinue or modify its products, including color, and will not be responsible in the event replacement products vary in color or gloss compared to the original product as a result of weathering or otherwise.

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

The warranty statements contained in this limited warranty set forth the only warranty extended by Enduris and are in lieu of all other conditions and warranties either expressed or implied including without limitation, the implied warranties of merchantability and fitness for a particular purpose. The provisions of this warranty shall constitute the entire liability of Enduris and the purchaser/property owner's exclusive remedy for breach of this warranty. In particular, in no event shall Enduris be liable to the purchaser/property owners for special incidental, indirect, consequential, or punitive damages arising from the use of Enduris products or the breach of any express or implied warranty.
